## Description of necessary first aid measures

**Eye contact**

Inhalation

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. **Skin contact**

#### Ingestion

For non-emergency personnel
