- (1) Maximum capacity 1000 lbs. (454 kg) per drum
- (2) Do not exceed rated capacity. Injury to persons or property may result from overloading and misuse.
- (3) Follow all OSHA requirements, particularly Section 1910.178a (5) regarding powered industrial trucks.
- (4) Adhere to all local codes regarding drum use and storage.
- (5) Before using this product, contact manufacturer of your industrial truck and obtain their written approval that the truck has the capacity to be used with this attachment.
- (6) DO NOT use to lift personnel or carry loads over people.
- (7) DO NOT leave with a load suspended in air unattended.
- (8) DO NOT remove or obscure capacity/warning labels.
- (9) Keep hands clear of drum clamping head.
- (10) Clamping head must be in full contact with drum rim prior to lifting.
- (11) Be certain rim of fiber or plastic drum is able to withstand the stress of drum lifting procedure.
- (12) Transport at lowest practical height possible.
- (13) Use extreme care when traveling on uneven floors.
- (14) DO NOT modify this product in any way.
- (15) Periodically inspect for damage and remove any damaged or malfunctioning unit from service immediately until repairs have been made.

Operating Instructions

- (1) Place unit on floor or flat surface easily accessible to fork truck. Be sure that "T" handles are sufficiently unthreaded to allow forks to enter pockets.
- (2) Carefully slide forks (do not use fork extensions) into drum grab's fork pockets as far as possible.
- (3) Hand tighten "T" handles to secure unit to forks (hand tool may be used but not necessary). Recheck bolts periodically during use for tightness.
- (4) Set angle of forks or carriage plate so that units are vertical or inclined slightly forward.
- (5) For lifting (2) drums, set drums approximately 23 inches apart.
- (6) Move unit towards drum until the Gator Grip firmly contacts the side wall of the drum. Note: three sets of holes in the top of the carriage allow for height adjustments of the Gator Grip to grab a drum.
- (7) Raise unit until the Gator Grip hook extends and clamps the chime of drum.
- (8) Move the drum(s) to the desired location and lower them to the floor. The Gator Grip will automatically release when the drums are on the floor.




Figure 3 (Gator Grip Mount Points)




Figure 4 (Single Fork Mounted Base Unit)
