Unpacking

When unpacking the Wesco Product, check carefully for shipping damage and missing parts. If damage has occurred or any parts are missing, file a claim with the delivering carrier within 24 hours and notify the dealer from whom the unit was purchased.

Warranty Repairs

If the unit does not work properly, contact your dealer or the factory (215-699-7031) for units less than 90 days old.

Non-Warranty Service

If units are older than 90 days, repairs can be made easily on site with factory supplied parts.

NOTE: Do not send units to the factory for service without first obtaining a "Return Merchandise Authorization" (RMA) number from the customer service department. We will not be responsible for merchandise returned without proper authorization.

Operating Instructions

- (1) Manually position lift pads 1 and 2 on side of drum.
- (2) Slowly raise crane making sure lift pads securely grip under drum chime.
- (3) Drum may now be lifted and transported.
- (4) Lifter is designed to allow placement of drums in a steel or poly over pack drum.
- (5) Lifter must be manually removed from drum after drum is in desired location.

- (1) Maximum capacity 1000 Lbs.
- (2) Do not exceed rated capacity. Injury to persons or property may result from overloading and misuse.
- (3) Do Not use on Open Head Drums


Warning

- DO NOT walk under elevated drums.
- Unit lift bar must be placed securely under drum chime or locking ring
- Periodically check for loose or worn hardware; If found replace at once.

Assembly Instructions

- (1) Line up holes of the Arm Support and Pivot Arm.
- (2) Slip pin (B) through the lined up holes.
- (3) Place washer (D) on Pin and insert Cotter Pin (C)
- (4) Bend Cotter Pin sufficiently to prevent it from coming out.

Note: Arm Support should pivot freely inside Pivot Arm. If it does not, lubricate lightly with silicone.
