## Description

The Wesco Open Head Drum Lifter (OHDL) is designed specifically for lifting 30 and 55 gallon steel or polyethylene drums. The Universal Drum Lifter (UDL) can load and unload 30 and 55 gallon steel or polyethylene drum into an "overpack" drum.

### Unpacking

**NOTE:** Do not send units to the factory for service without first obtaining a "Return Merchandise Authorization" (RMA) number from the customer service department. We will not be responsible for merchandise returned without proper authorization.


## **General Safety Information**


Warning: The Wesco OHDL and UDL lifters are intended for specific functions. Please adhere to the following instructions to insure safe and proper use.

- (1) Maximum capacity 1000 Lbs.
- (2) Do not exceed rated capacity. Injury to persons or property may result from overloading and misuse.
- (3) Do not use on FIBER DRUMS!

# **Operating Instructions**

- (1) <u>55 Gallon drums</u> The lifter arm must be secured to the unit through the OUTER hole (Fig. 1). <u>30 Gallon drums</u> – The lifter arm must be secured to the unit through the INNER hole (Fig. 2). <u>Overpack Drums</u> – Fig. 3 shows UDL (P/N 240062) for loading/unloading drums into an "Overpack"
- (2) To lift, lower the unit onto the drum while making sure the 3 lifter arms over hang the rim of the drum (Fig. 4).
- (3) Raise the unit whole making sure the 3 lifter arms grab the drum rim (Fig. 5). Lift drum just off the ground and check that the arms are secure before continuing to lift.
- (4) To release unit from drum, raise unit until slack is out of the hoist chain. Grab a lifter arm and rotate upwards and out of the way. Push towards remaining lifter arms to disengage drum (Fig. 6).
