The Wesco Drum Rack is designed specifically for economical stacked storage of 55 gallon drums in the horizontal position. It features easy access from all four sides, providing easy movement and placement.

#### Unpacking

**NOTE:** Do not send units to the factory for service without first obtaining a "Return Merchandise Authorization" (RMA) number from the customer service department. We will not be responsible for merchandise returned without proper authorization.

## **General Safety Information**

Warning: The Wesco Drum Racks are intended for specific functions. Please adhere to the following instructions to insure safe and proper use.

- (1) Maximum capacity including drums:
  - 1600 lbs. (2 Drums) (For DR-2 P/N 240026 units)
  - 2400 lbs. (3 Drums) (For DR-3 P/N 240027 units)
- (2) Maximum Stack Height (immobile): 4 high.
- (3) Maximum Stack Height when moving: 2 high.
- (4) Do not exceed rated capacity. Injury to persons or property may result from overloading and misuse.
- (5) Do Not use on Plastic Drums

#### Warning

- Make sure all drums are in good condition.
- Only stack racks on fully loaded racks. **Never** stack on to a rack containing only one drum.
- Do Not move stacks of 3 or more high under any conditions.
- When using fork trucks to move loaded racks make sure forks are set at maximum usable width to insure stability
- It is strongly recommended to stack racks one at a time.
- Periodically check for loose, damaged or worn hardware; If found replace at once.
- Intended for use with most currently available 55 gallon steel drums. Minimum recommended drum wall thickness for the bottom layer of drums on a 3-high stack is 20 gauge; on 4 high stack it is 18 gauge. Use of drums with walls that are too thin may not be safe.

**Note:** Check with your supplier(s) if you are not sure of the specifications for your drums.



## Assembly

- (1) Place the Flat Washer (5) on the Bolt (3)
- (2) Insert the Bolt (4) through the hole in the Side Frame Weldment (1), then through the Cross Brace Weldment (2). Put the Nut (4) on the end of the Bolt (3).
  Note: Be sure the Flat Washer is on outer side of the Side Frame Weldment.
- (3) Assemble the unit together in this manner, loosely using all Bolts.
- (4) Tighten all Bolts, however do not over tighten.
