If the unit does not work properly, contact your dealer or the factory (215-699-7031) for units less than 90 days old.





Drip Pan Assembly

- (1) Install the Drip Pan Coupling (A) to your drum.
- (2) Slide the Pump Suction Tube (B) through the Drip Pan Coupling into the drum leaving approximately 6-8 in. (153-204 mm) extended above the drum head as shown.
- (3) Tighten the Coupling screws (C) to hold the tube in place.
- (4) Screw the threaded Drip Pan Pipe into the Coupling.
- (5) Install the Drip Pan to the Drip Pan Pipe. Open the drip Pan Cover and your unit is ready for use.
