The Wesco Non-Sparking Rotary Pump is designed to transfer products out of storage. The pump features a rugged aluminum construction, 47" 3 piece steel plated suction tube and phenolic veins. It is supplied with a 48" PVC discharge tube and is self priming. This pump handles medium viscosity petroleum based products up to 3000 SSU. Such as gasoline, light oils, and anti-freeze


Application Information

WESCO iron pumps have wetted parts fabricated from cast iron, steel, phenolic (270021 & 272212 only) and neoprene (272210 only) materials. These pumps were designed primarily for the transfer of fuel oil products. It should be noted that these pumps can only be used for chemicals which are compatible with cast iron. steel, neoprene and phenolic.

We recommend that if a question arises, the user contact the supplier of chemicals to determine if these pumps are compatible with those chemicals. WESCO is unable to offer specific recommendations for chemical usage.

Drip Pan (P/N 272211) Assembly

- (1) Install the Drip Pan Coupling (A) to your drum.
- (2) Slide the Pump Suction Tube (B) through the Drip Pan Coupling into the drum leaving approximately 6-8 in. (152.4-203.2 mm) extended above the drum head as shown.
- (3) Tighten the Coupling screws (C) to hold the tube in place.
- (4) Screw the threaded Drip Pan Pipe into the Coupling.
- (5) Install the Drip Pan to the Drip Pan Pipe. Open the drip Pan Cover and your unit is ready for use.
